



# **Standard Flooring Adhesive**



## DESCRIPTION

Ultrabond ECO 20 has been designed to provide both value and performance in a standard flooring adhesive. Its unique formulation provides ample working time for installing felt-backed vinyl sheet flooring. Ultrabond ECO 20 also has been designed to install most basic carpet in residential and light commercial applications. Ultrabond ECO 20 is suitable for installing carpets with ActionBac, jute, latex-foam and sponge-rubber backings. In addition, Ultrabond ECO 20 is ideally suited for flooring installations that may need removal within 2 to 3 years, such as installations in rental properties as well as main-street commercial and retail outlets.

#### WHERE TO USE

- For the installation of carpet with jute, polypropylene (ActionBac), latexfoam and sponge-rubber backings; residential mineral fibrous felt-backed vinyl sheet goods; and cork underlayment
- Interior residential applications (such as rental apartments and condominiums)
- Interior light commercial applications (such as general office areas, hotel rooms and small retail stores)

#### LIMITATIONS

- . Do not install over any substrates containing asbestos.
- . For interior installations only
- Do not use to install nonporous floor coverings over nonporous surfaces. •
- Do not use to install solid vinyl flooring products.
- Do not use to install vinyl-backed carpet products. •
- Do not apply over any adhesive residues, including cutback adhesive.
- Do not install when the moisture vapor emission rate (MVER) exceeds 5 lbs. per 1,000 sq. ft. (2,27 kg per 92,9 m<sup>2</sup>) per 24 hours, when using the anhydrous calcium chloride test (ASTM F1869).



- Do not install when the relative humidity (RH) of the concrete slab exceeds 80% (ASTM F2170).
- Do not install in areas with known hydrostatic moisture problems.
- Use only when the substrate temperature is between 50°F and 90°F (10°C and 32°C), and when the ambient RH is between 20% and 80%.
- Do not install unless the temperature of the prepared concrete slab is at least 5 degrees Fahrenheit (2,8 degrees Celsius) above the dew point to avoid condensation.

## SUITABLE SUBSTRATES

- Exterior-grade plywood, Group 1, CC type
- Other approved wood underlayments (per manufacturer recommendations)
- Concrete and cement terrazzo
- Cement-based self-leveling underlayments and patching compounds
- Embossing levelers applied over existing and fully bonded ceramic tile and sheet vinyl
- A single layer of fully bonded vinyl composition tile (VCT)
- Primed gypsum underlayments that meet the ASTM F2419 requirements for compressive strength

Consult MAPEI's Technical Services Department for installation recommendations regarding substrates and conditions not listed.

## SURFACE PREPARATION

- All substrates must be properly prepared, structurally sound, dry, solid and stable.
- Substrate should be clean and free of dust, dirt, oil, grease, paint, curing agents, concrete sealers, loosely bonded toppings, loose particles, old adhesive residues, and any other substance or condition that may prevent or reduce adhesion. All surfaces must be level, even, flat and smooth.

#### MIXING

Choose all appropriate safety equipment before use. Refer to the Safety Data Sheet for details.

Ready to use; no mixing is necessary.

## **PRODUCT APPLICATION**

Read all installation instructions thoroughly before installation.

- 1. Select the appropriate notched trowel (see the "Approximate Coverage" chart).
- 2. Spread adhesive evenly over the subfloor, keeping the trowel at a 45-degree angle to the subfloor.

- For porous substrates, install the flooring material into the adhesive while it is still wet. Over nonporous substrates, allow 20 minutes of drying time for the adhesive to tack up before placing flooring material.
- 4. Install flooring per the flooring manufacturer's instructions.
- 5. Periodically confirm the adhesive transfer to the backing by lifting the flooring material.
- 6. Roll the flooring with the recommended-weight roller across the width and length of the flooring surface.

## CLEANUP

- Promptly clean any adhesive smudges from the flooring material's surface with water while the adhesive is still fresh/wet.
- Clean tools with water while the adhesive is still fresh/ wet.
- Clean with mineral spirits once the adhesive has dried. Use caution with mineral spirits, which may be harmful to some materials.

#### PROTECTION

• Protect from heavy traffic for at least 24 hours.
