WHAT IS COVERED

Warranty for Residential Use

ECOFORST Cork Flooring's high-quality standards enable it to provide a comprehensive warranty covering its cork floor products. This warranty covers all ECOFORST Cork Flooring purchased after January 1, 2020. Our warranty extends (beginning on the purchase date of the flooring) for the lifetime of the product to the original purchaser for as long as he or she continues to the own the home in which it was originally installed.

OUR WARRANTY COVERS:

Overall Panel Quality Guarantee

Each panel is manufactured to our high-quality standards and undergoes a thorough inspection at our plant. We suggest that our customer and their installer inspect each panel prior to installation. If you are not completely satisfied prior to installation, we will replace the panel free of charge. This warranty covers visual defects in the panel, with the exception of normal color variations due to the use of natural components.

Structural Guarantee

Each of the panels is made with a specially developed bonding system to maintain its quality and is guaranteed against structural failure. In case of such failure, we will repair or replace it (at our option) at no charge. Moisture and Dryness Protection Guarantee

Our panels have been made to withstand normal moisture and dryness variations and are guaranteed against damage caused by normal moisture and dry conditions (within the normal 40%-60% relative humidity range). This warranty does not cover damage caused from floods or wet mopping, leaky appliances or ceilings, stagnant water, or improper installation (see ECOFORST Cork Flooring Installation Instructions).

Performance Guarantee Over Radiant Heat

Our Structural and Moisture Guarantees will cover the application over radiant heat subfloors, so long as the subfloor temperature does not exceed 85 degrees Fahrenheit.

ECOFORST Cork Flooring's 25-Year Finish Limited Warranty

ECOFORST Cork Flooring has a durable no-wax surface of multiple layers of a UV coating. We guarantee the finish will not wear through for 25-Years from date of original purchase, when maintained and installed using our recommended instructions. The warranty applies only to a defect covering 10% or more of the installed floor. It is based on normal residential use and does not cover damaged caused from spiked heels, pet, erosion, dents, gravel, scratches from roller chairs, furniture or improper maintenance. ECOFORST Cork Flooring reserves the right to recoat, replace, or repair the defect.

HOW TO MAKE A CLAIM:

ECOFORST Cork Flooring products are made with the goal of complete customer satisfaction. However, if you have a claim covered by our warranty:

- 1. Send a notice of the claim to the ECOFORST Cork Flooring Dealer where you made the purchase, within the applicable time period.
- 2. If the applicable panel has not yet been installed return the panel with your claim.
- 3. Make sure the installation and maintenance instructions were followed. If the defective panel has been installed and is covered by the warranty, we reserve the right to inspect the panel
- 4. Keep your proof of purchase (it is required to make a claim) for our review.

EXCLUSION FROM COVERAGE

Our warranty does not apply and ECOFORST Cork Flooring will not be in any way liable in the event of:

- <u>Normal Variations</u> Cork is a natural product and variations of grain or color are normal occurrences. Color changes in cork should be expected as the floor ages. Therefore, color inconsistency between samples, replacement product, ECOFORST Cork Flooring (or Imagery Cork) pictures or images and ECOFORST Cork Flooring or replacement product like all products of nature are normal, therefore the warranty will not apply to these variations. Loss of finish gloss is a part of the natural wear of the floors. Further, cork will contract or expand naturally due to changes in temperature and humidity.
- <u>Improper Installation or Maintenance</u>- Installation and maintenance must be in accordance with our instructions.

- <u>Improper Use Alterations</u>- We do not assume responsibility for any flooring damage caused by misuse, abuse or damage by accident or other events beyond our control. The warranty does not cover damage caused by high-heeled shoes, heavy furniture or equipment, pets, damage caused by impact, scratches scarring caused by sharp or pointed objects, stains, worn out shoes, roller chairs, furniture, or damaged by excessive or continued exposure to direct sunlight.
- <u>Extreme Environmental Conditions</u>- We are not responsible for extreme conditions such as exposure to extreme heat, moisture, dryness or rapid fluctuations in any such conditions.

The warranty applies only to a defect covering 10% or more of the installed floor. It is based on light commercial use and does not cover damaged caused from spiked heels, pet, erosion, dents, gravel scratches from roller chairs, furniture or improper maintenance. ECOFOREST Cork Flooring reserves the right to recoat, replace, or repair the defect.

NOTE: **5-YEAR LIMITED COMMERCIAL WARRANTY** is a "pro rata" warranty. The refund or credit declines as the warranty period decreases, therefore the warranty is reduced by the time after the flooring is initially purchased.

This Warranty is applicable in the following Commercial Areas (Note: All areas with immediate access to the outdoors or street traffic must have other flooring for all areas within 10 feet from said access):

- 1. Offices
- 2. Hotel Rooms/Suites
- 3. Retail Shops
- 4. Conference Rooms

This **5-YEAR LIMITED COMMERCIAL WARRANTY** does not cover high traffic commercial environments; mall walk ways, airports, etc.
